# CAOAC Minutes March 16, 2003

## EXECUTIVE MEETING

The meeting was called to order by Paul McIntosh (President) at 1100 hours in Waterdown, ON. The following executives were in attendance: Udo Rohmann (1st Vice-president), Tony Bernard (2nd Vice-president), Jennifer Bawden Miller (Treasurer), Sarah Langthorne (Corresponding Secretary), Dave Boehm (Past-president/Newsletter Editor/Webmaster) and Micia Burden (Recording Secretary). Also present were Wayne Rakestrow (Awards) and Randy and Teri Seufert (TFCEC)/Convention 2003.

## COMMITTEE REPORTS

**Awards:** Wayne outlined to the executive the business that was discussed at the earlier awards meeting.

**Code of Ethics change proposed:** On page 8041 1) “Any member of the Awards Committee and his/her immediate family are not eligible to receive any CAOAC recognition award during their term”. After a brief discussion re. the Newsletter awards and Web awards and the fact that they are judged or will be judged externally by an unbiased judge(s), a motion was made.

### Motion 200303-01

To add the clause “with the exception of when the award is judged outside of CAOAC” to page 8041 1) “Any member of the Awards Committee and his/her immediate family are not eligible to receive any CAOAC recognition award during their term” in the CAOAC Binder.

Motioned by Dave Boehm (Past President/Newsletter/Webmaster), seconded by Tony Bernard (2nd Vice President). Voted on and carried.

**Promotion of Awards:** Dave Boehm (Past President/Newsletter/Webmaster) was asked to add a “Feature of the Month” sidebar to the Newsletter outlining the different awards and how to apply. This will also be posted on the web site.

**Web Award:** (taken from the award meeting minutes) To date no comments have been received from any members of CAOAC; therefore we assume that the proposal is fine as is. There remains only one problem - that of judging the award.

Wayne Rakestrow has contacted Durham College and they have a Multimedia/Web program. He has sent them our guidelines but has had no reply to date. Wayne felt it would be worthwhile to wait and see what feedback we might get. He also suggested that other members of the committee could check with colleges and universities in their areas to see if there is any interest in judging this award. Discussion about the ‘good fish keeping’ seal of approval was discussed. Pros and cons were discussed - will the seal “water down” this award and could we combine the idea of recognition and competition for this award? And finally, how to actually judge this award.

Results of discussion: A motion to combine both aspects of the award—competition and recognition—was made as follows:

### Motion 200303-02

If a web site meets a certain criteria it will be awarded an automatic “seal of approval” and the top points getter will receive the award.

Motioned by Randy Seufert, seconded by Paul McIntosh (President). Voted on and carried.

How to judge the sites was discussed with the following recommendations: that the site be judged according to a point system (much like the newsletter award is judged) and that clubs include on their sites a "What's New on the Site" page so that judging could be streamlined. It was also suggested that the judges be asked for input on how to judge this award. The judging could also be split over the year - first half of the year by one set of students and the second half of the year by another set of students. This could result in a good balance.

Recommend acceptance of this award at this year's Convention and that the award start in January of 2004.

**CAOAC Convention:** All OK. Publication coming soon.

**Membership:** Willowdale has renewed and both Regina and London have been contacted via e-mail. London has said they are rejoining but nothing has been received to date. Nothing from Regina. Wayne Rakestrow mentioned that he has another email contact for Regina and Miecia will try again using this e-mail address.

**Treasurer's Report:** Jennifer Bawden Miller (Treasurer) has sent Rein his cheque and after discussion a motion was made by Jennifer Bawden Miller (Treasurer), seconded by Udo Rohmann (1st Vice President) .

**Motion 200303-03**

**T**hat Rein be given a float of \$100 to cover this monthly expenses for printing the Newsletter.

Voted on and carried. Miecia will e-mail Jennifer an example of what the Treasurer's report should contain i.e., debits, credits, committed funds and working balance for future reports.

The picture should (obviously) represent the aquarium and/or herp hobby with fish, plants and other animals. The winner will be credited on the calendar and will get a calendar gratis.

Attempts are being made to collect outstanding debts.

General minutes from February accepted as published on a motion by Randy Seufert (TFCEC/CAOAC/FAAS Liaison) seconded by Wayne Rakestrow (Awards). Voted on and carried.

**Correspondence:** None from Sarah Langthorne (Corresponding Sec).

Paul McIntosh (President) discussed the survey from Statistics Canada and we decided not to participate. (Voted 5 to 1 not to participate.) Noted in the survey was that participation was voluntary.

## COMMITTEE REPORTS

**Archivist:** Nothing to report.

**AH Directory:** Nothing to report.

**Awards:** Wayne reported the following:

AHAP & BAP had only one AHAP application and 3 BAP applications. This is quite a drop from previous years.

Recognition Awards for Author's, Advanced Author's, Hobbyist, Junior Hobbyist and Service Award were selected.

**Newsletter Award:** Had 4 clubs participating. Judging was done by Durham College with an honorarium of \$75.00 paid for the judging. Durham College will also judge next year. The judging form that was used by the college will be published in the binder after certain changes that were proposed are made. **This chair will not accept copies of the newsletter from clubs.** It is the responsibility of the club to collect and submit.

**Web Award:** We have had no comments or proposals from clubs. The only hurdle now to be faced is how to get the award judged. We adopted a motion to award an annual award as well as a "**Good Fish-Keeping Seal**". To that end, a Durham College Multimedia Web Program professor has been contacted to see if we can pattern the judging much like we have for the Newsletter award. Other colleges will also be contacted. In summary, this award is coming.

The motion 200210-05 that all applicants for the Aquatic Horticulturist Awards be required to register their propagations with the AH Directory before the award is granted will start next year for the 2003 awards.

**Binder:** Binder # 172 was given to Tony Bernard (2nd Vice President/AH Directory) as a second

binder for CRLCA. The next update is scheduled for the June meeting.

**Breeder's Directory:** Submissions received from Winnipeg and Hamilton. A list of "First In" certificate recipients will be published in the newsletter.

**CAOAC/FAAS:** Nothing to report.

**Convention 2003:** Information is on the web site and also in this newsletter as a separate flyer. If you are interested in sponsoring a class see Jennifer Bawden Miller. The cost is \$30 Canadian. The bulletin will be available as soon as all the speakers have been confirmed.

### HOW TO APPLY FOR A **BREEDER AWARD**

1. Make sure you keep precise records of all spawnings and even have an Executive member of your local Club/Society verify the spawning.
2. Before applying for a Breeder Award, check to see if in fact you meet the requirements of the particular award you are applying for. Remember that you are applying for a C.A.O.A.C. Breeder Award. This may, in fact, be different from your Club/Society's Breeder Award.
3. You may apply for as many levels in the Breeder Award Program as you are qualified for in any one year.
4. When applying for a Breeder Award, fill out the [APPLICATION FOR BREEDER AWARDS](#) form on page 1161 of your Club/Society's C.A.O.A.C. Information Binder. Part A of the form must be completed by you. Part B is to be completed by an Executive member of your local Club/Society. **MAKE SURE THAT THE APPLICATION IS LEGIBLE.**
5. A Spawning Resume (Section C) must accompany the Application. This form is on page 1163 of your Club/Society's C.A.O.A.C. Information Binder, if you care to use it. If you wish to send a computer generated list, make sure it includes the same data requested on Page 1163; otherwise it will not be accepted.
6. Make sure that the form has been submitted to your local Club/Society's Regional Representative on the Awards Committee by the **FEBRUARY C.A.O.A.C. GENERAL MEETING.**
7. At the Awards Committee meeting, each application is reviewed to ensure that the qualifications are met for the award applied for. Again, the Awards Committee stresses that you include as much information as possible. Too little could eliminate you from receiving the award.
8. Check the "Rules for Applying for a Breeders Award", page 8063 in your Club/Society's C. A. O. A. C. Information Binder.
