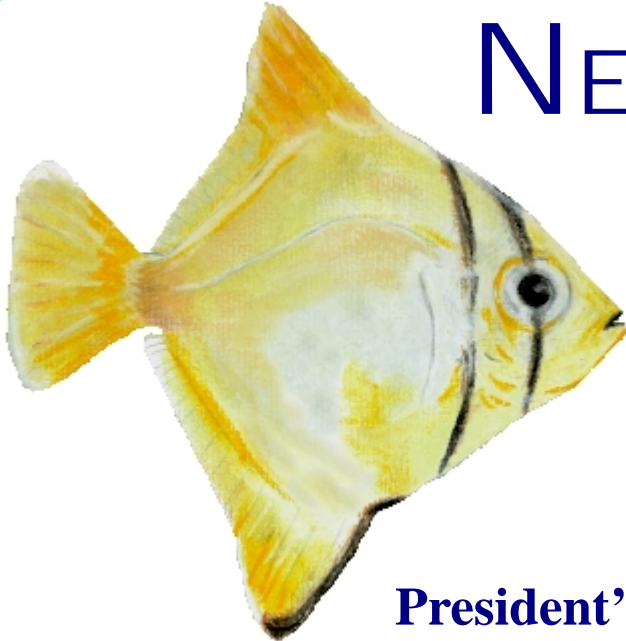

CAOAC Minutes December 12, 2004

EXECUTIVE MEETING

The meeting was called to order by Paul McIntosh (President) on December 12th, 2004 at 1000 hours in Waterdown, ON.

The following executives were in attendance: Paul McIntosh (President), Tony Bernard (1st Vice president), Randy Seufert (2nd Vice), Jennifer Bawden Miller (Treasurer), Sarah Langthorne (Corresponding Sec), Miecia Burden (Recording Secretary) and Dave Boehm (Past President). Also present was Teri Seufert (TFCEC).

Membership: A list of clubs requesting membership and insurance was given to Jennifer Bawden Miller (Treasurer) and Paul McIntosh (President). Both Calgary and Willowdale have sent e-mails indicating that they will probably be re-joining and will want insurance but nothing has been received to date. In keeping with our stated policy both clubs will be asked to pay a late filing fee since the deadline of November 21st was missed and there has been plenty of notices sent via email. No reply has been received from Nova Scotia or Oxford re: membership or insurance. Oxford has not requested insurance in the past and Nova Scotia was late in replying last year due to a problem with meeting dates. Tropical Fish Breeders Association will not be re-joining this year. If Calgary and Willowdale re-join and take the insurance we will have 19 clubs with 17 requesting insurance. Add to that figure Oxford bringing the total number of clubs to 20.

Charter framing: A receipt and thankyou note will be sent by Jennifer to Ray Lucas thanking him for the donation. The donation and Ray's picture were also featured on the front page of the last newsletter. Randy also thanked Ray when he saw him last week.

Pond & Bog Plants: After discussion about the question of why does there have to be a separate program for bog and pond plants, the executive recommends to the Awards committee that CAOAC policy be that genus and species be recognised by the CAOAC Awards committee, given points and listed in the AH Directory but varieties and sub-species not given points but listed in the AH Directory. With the demise of African Diving for alleged poaching in Tanzania, the departure of AC Aquaculture's Thorsten Reuter, and the reduction of direct flights by BA into Malawi and weekly only flights in Lusaka have made importation quite difficult.

Toby Veall and Stuart Grant remain our shippers from Africa and we have shipments arranged for the next few months with them.

We have received a number of shipments in February, March and April 2004 and are awaiting our most recent shipment from Lake Tanganyika prior to XMAS with a Malawi shipment planned for late January.

Membership in CRLCA continues to grow. We have 645 active members.
