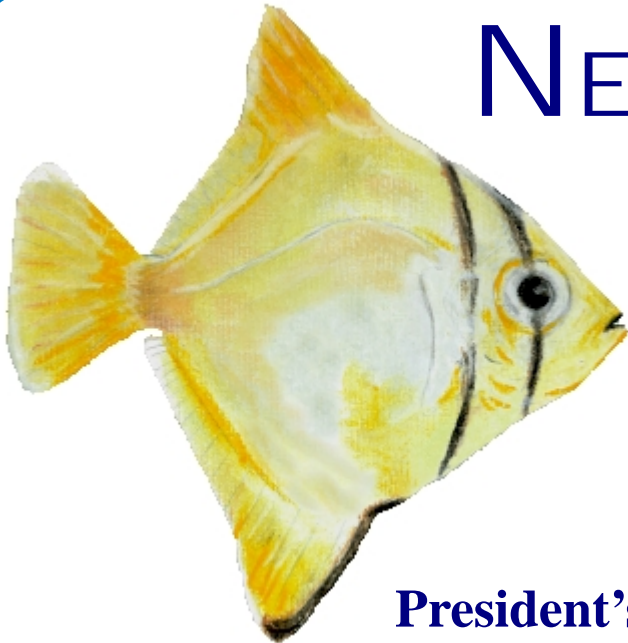

# CAOAC Minutes January 16, 2005

## EXECUTIVE MEETING

**The meeting was called to order** by Paul McIntosh (President) on January 16<sup>th</sup> 2005 at 1000 hours in Waterdown, ON.

**The following executives were in attendance:** Paul McIntosh (President), Tony Bernard (1st Vice president), Randy Seufert (2nd Vice), Jennifer Bawden (Treasurer), Sarah Langthorne (Corresponding Sec), Miecia Burden (Recording Secretary) and Dave Boehm (Past President). Also present was Teri Seufert (TFCEC).

**Membership:** Most clubs have renewed membership and taken out insurance. No reply from Oxford, Nova Scotia or Calgary.

**In trust monies:** Dave Boehm suggested a few changes to the agreement. Miecia will correct the document and bring a copy to the next meeting for Terry Little as a former Brant club member to sign. Motion to accept the agreement as amended made by Randy Seufert (2nd Vice/CAOAC/FAAS Liaison), seconded by Dave Boehm (Past President/Newsletter/Webmaster). Voted on and carried.

**Spring Auction:** The hall in Burlington has been booked and Jennifer offered to be auction chairperson. Miecia will make up flyers for the next meeting. We will follow Hamilton auction format since it is their program we are going to be using. Discussion about having three auctions linked by the CAOAC name so close together in the spring. CAOAC auction on April 3, Durham Region auction on April 10 and CAOAC Convention auction May 15<sup>th</sup>. Concern that we would be asking the same companies and dealers for donations was mentioned as a specific problem. A suggestion that the CAOAC auction in the spring could be limited to just hobbyists sellers and CAOAC would not contact the com-

panies for donations was discussed and will be proposed to the Durham group at the general meeting. Hopefully this will be viewed positively by the Durham group this afternoon at the general meeting.

**CAOAC Finances:** Discussion about CAOAC finances and just where we can cut costs. Randy and Jen will be working on the budgets and hopefully will have something for the next meeting. Various options were proposed for the two largest spenders - Awards and Binder. We need a breakdown of costs from Wayne and Paul McIntosh (President) will contact Wayne regarding this. The Binder costs could be reduced if the binder was put upon the web and club could download the information as posted. Miecia and Dave Boehm will work on this over the next few months. A suggestion that we print the directories on alternate years and possibly charge for hard copies of each was discussed and alternately both directories can be put on the web site and clubs could download as needed.
