

CAOAC Minutes April 17, 2005

EXECUTIVE MEETING

The meeting was called to order by Paul McIntosh (President) on April 17th 2005 at 1030 hours in Waterdown, ON.

The following executives were in attendance: Paul McIntosh (President), Sarah Langthorne (Corresponding Sec) and Miecia Burden (Recording Secretary).

Executive absent: Tony Bernard (1st Vice president), Randy Seufert (2nd Vice President), Jennifer Bawden (Treasurer) and Dave Boehm (Past President).

Treasurer's report: Submitted via email from Jennifer Bawden (Treasurer) with Tony Bernard (1st Vice President) assisting (see report on page 4)

The working balance is \$2,083.81.

Paul will collect all bills and monies and send them to Jennifer Bawden (Treasurer) after this meeting so that she can create a year-end report for the annual meeting in May. Miecia suggested that the date on the report should read April 11th or April 17th since the report includes monies from the Spring Auction held April 3rd.

Spring Auction: Submitted via email from Jennifer Bawden (Treasurer) with Tony Bernard (1st Vice President) assisting. (See report on page 4)

Total profit was \$1,411.06.

Turn out was lighter than expected, probably due to the lousy weather that day but it looks like we did OK.

Annual Reports: are due at the April meeting from all committee heads. The treasurer's report is due at the end of April. Send all the reports to Dave Boehm who will create the Annual Report.

Elections: Will take place at the General Annual meeting in May at the Convention. Nominations are closed at the break today and will be re-opened at the annual meeting for **uncontested positions only**.

Convention 2005: Durham reps will be here this afternoon with information.

Ways & Means: Suggests that we set a permanent date on

which to hold an annual CAOAC auction. Dates suggested were September 25th or October 23rd. We will check with the reps at the general meeting to see if there is a conflict with any club functions.

Binder: Bylaws will be updated for the next release. Getting the relevant pages of the binder on the web site is an on-going project for Dave Boehm (Webmaster/Editor/Past Pres) and Miecia Burden (Recording Secretary/Binder/Membership).

Judges: Meeting scheduled for April 24th at Brian & Susan Glazier's in Burlington at 12 noon. Judges, apprentices, executive and anyone interested is invited to attend. All four apprentice judges have Judging Binders. Apprentice judges are Tony Bernard, Paul McIntosh, Ron Wentworth and Heather Scroop. Question from the executive – "Are all of these apprentices actively participating in the program?"

Awards: A replacement BAP certificate has been made for Ron Bishop and will be given to him at the general meeting.

COMMITTEE REPORTS

Archivist: The CAOAC revolving trophies and CAOAC history paraphernalia that Paul has amassed will be on display at the convention in Durham.

AH Directory: Nothing to report.

Awards: Expenses report read by Paul McIntosh (President/Archivist). See executive minutes for the report. In an effort to cut expenses the awards were made a little smaller this year but are still of good quality. Discussion about the Newsletter award and whether it is worth the expense of judging and trophy cost. There seems to be poor participation in the last three years. Only 4 or 5 clubs have sent in material to be judged.

Also mentioned was the need of a regional rep for region 4, which includes TFCEC, Hamilton and St Catharines. Discussion about how the reps contact the clubs in their area and a suggestion that a package about the awards be mailed out by the rep to the club rather than doing this contacting by email. It sounded like several clubs had not heard about the awards because the person contacted had not passed on the information to the club.


