Minutes of Meetings

June 26th , 2005

EXECUTIVE MEETING

The meeting was called to order by Paul McIntosh (President) on June 26, 2005 at 1000 hours in Waterdown, ON.

The following executives were in attendance: Paul McIntosh (President), Tony Bernard (1st Vice President), Randy Seufert (2nd Vice President), Jennifer Bawden (Treasurer), Sarah Langthorne (Corresponding Sec) and Miecia Burden (Recording Secretary).

Executive absent: Dave Boehm (Past President).

Guests: Teri Seufert (TFCEC) and Samantha Bawden.

Udo Rohmann (Brampton/Programs), Terry Little (FRP/Open Show) and Bill Irwin (Judges) joined the meeting in progress.

BOD Appointments: Paul has spoken to several of the reps about taking on some of the chairs for the different committees. All chairs will be accepted at the general meeting this afternoon.

Changes to the bylaws that were motioned over the past few years have been done in section four of the Information Binder and will be part of the next update to be released this fall.

Discussion about Honorary membership and the criteria as printed in the bylaws resulted in a *motion (200506-01) that we waive bylaw 13, B), I, 1) so that the person being honoured will not be alerted that this is being done. Motioned by Randy Seufert (2nd Vice President), seconded by Terry Little (FRP/Open Show). Voted on and carried.* The awards committee will be asked to have a plaque made for this occasion to be presented at the 2006 Convention. This will be a first for CAOAC.

Correction to Treasurer's Annual Report: Miecia

Burden (Recording Secretary/Binder/Membership) mentioned that there is a correction to be noted on the annual report. In the expenses column \$107.12 should have been debited against the Ways and Means committee rather than the Recording Secretary.

All chairs will be asked to submit a budget request for their committee at the September meeting for discuss and acceptance.

COMMITTEE REPORTS

Archivist: *Motion 2005-05-02 – to accept as chair Paul McIntosh – Motioned by Udo Rohmann (Brampton/Programs), seconded by Tony Bernard (1st Vice pres/AH Directory). Voted on and carried.* Nothing to report.

AH Directory: Chair is open. Tony Bernard (1st Vice President) is stepping down as chair. Thanks to Tony for his work on this committee. Discussion about this program and the problems that Tony has experienced in trying to get Dave to pass on the information about the program. Miecia volunteered to talk with Dave about the program and what needs to be done with it.

Awards: *Motion 2005-06-03 – to accept as chair Wayne Rakestrow. Motioned by Tony Bernard (1st Vice President), seconded by Barry McKee (Durham). Voted on and carried*

Wayne has sent an awards update for the Information Binder to Miecia Burden that will be included in the update this fall. Reps from Region #4 are reminded that they need to get a volunteer from within their clubs to represent them on the Awards committee. Tropical Fish Club of Erie County, St Catharines and Hamilton & Region Aquarium Society are the clubs in this region.

Binder #214 has been sent to East Coast Aquarium Society. A fairly large update will be issued this fall which will include the corrections to the bylaws that have been motioned over the past few years. Diana Causton (Durham) reports that she has turned one of the Durham binder's over to Keith Brown their new president. Miecia requested that they send her an updated membership form so that the information can be changed in the CAOAC records. Clubs are requested to check the information in Section 9 that pertains to their club to make sure it is correct and if it needs updating to please let her know ASAP.

Breeders Directory: *Motion 2005-06-05 – to accept as chair Tom and Pat Bridges. Motioned by Wayne Cole*

(Sarnia), seconded by Tony Bernard (1st Vice President). Voted on and carried.

Discussion lead by Tom regarding the confusion between submissions to the directory and submissions to the awards committee. Clubs seem to be confused as the difference between these two committees. The directories (this also pertains to the AH Directory) **list any breeding or propagation of fishes and plants** as submitted by hobbyists in the CAOAC clubs. The Directory does not administer the awards. It is possible that some of these breedings and propagations are not recognized by the Awards committee as part of its program i.e. Variations of species or color morphs. The awards committee (at one time) required that any fish breeding that was being submitted as part of an application for an award had to be registered in the Directory but that rule has since been rescinded. **The two committees are not connected and reps are asked to make sure that their clubs are aware of this.** Submissions to the directory can be made at any time during the year but submissions for breeding awards are made once a year at the February meeting using the forms found in Section 11 of the Information Binder.

CAOAC/FAAS: Motion 2005-06-06 – to accept as chair Randy Seufert. Motioned by Udo Rohmann (Brampton/Programs), seconded by Terry Little (FRP/Open Show). Voted on and carried.

Nothing to report.

At this time Jennifer Bawden (Treasurer) presented Randy Seufert (2 Vice Pres/FAAS-CAOAC) with the Hobbyist of the Year Award that was awarded at the CAOAC Convention in Durham last month. Unfortunately Randy and Teri had to miss the Convention due to Teri's surgery. Congratulations.

Convention 2006 – Terry Little (LondonAqSoc/FRP/Open Show) reported that the London Aquaria Society is honoured to have been chosen to host the 47th annual CAOAC convention next year. Plans are well in hand and progressing nicely. There will be 51 classes of fish. Sponsorships are being sought. Price is \$30.00 per class and \$60.00 for the larger trophies. See Terry ASAP for choices. Ticket cost is being worked on – trying to keep it about \$75.00 which will include two banquets and the speakers. The speakers that are being looked at have never been heard at Convention before and will be announced ASAP.

Fish Rescue Program: Terry Little (LondonAqSoc/FRP/Open Show) is stepping down from this position so it is open. Thanks to Terry Little (FRP/Open Show) for all the work he has done in the past to get this committee off to a good start. Tony Bernard (1st Vice President) volunteered to take on this committee. Motion 2005-06-07 – to accept as chair Tony Bernard (1st Vice President). Motioned by Wayne Cole (Sarnia), seconded by Diana Causton (Durham). Voted on and carried with one opposed (but we're not counting that one Jen. Sorry!!!)

A pair of 16 inch oscars in the Hamilton area are looking for a home. Suggestion that we advertise them on www.pricenetwork.com was made. Apparently this is an excellent website for posing for all manner of club related functions etc.

Judges: Motion 2005-06-08 – to accept as chair Bill Irwin. Motioned by Tony Bernard (1st Vice President/FishRescueProgram), seconded by Diana Causton (Durham). Voted on and carried.

Bill reported that letters have been sent to all apprentice judges asking for verification of their judging status but that few replies had been received to date.

Motion 2005-06-10 – to accept as chair Miecia Burden. Motioned by Terry Little (LondonAqSoc/Open Show), seconded by Barry McKee (Durham). Voted on and carried.
