Minutes of the Meetings

June 22nd 2008

Treasurer's Report: read and discussed by Dave Boehm (Treasurer/AHDir/Webmaster). See general minutes for report. After checking the treasurer's report it was noted that we have never received the extra insurance money from the Mississauga Fish Club as requested in March of this year. Due to an unfortunately situation that developed in that we were unable to obtain an outside panel to judge the Web Award the awards committee took on the task of judging this award so that it at least could be awarded for the 2007 year. Dissatisfaction regarding the judging of both of the Newsletter and Web Awards has been voiced by some club members who were not happy with the outcome of these competitions. This will be discussed further at the general meeting. The problem of obtaining unbiased and qualified judging for both the Newsletter Award and the Web Award will be addressed at the next awards meeting slated for the fall. Thanks to Paul McIntosh who took on this committee last year – it is quite a learning curve and due to his efforts we were able to present awards in 2008.

Web conferencing: Using web or telephone conferencing at the CAOAC meetings to involve both the western and eastern clubs was discussed at the AGM this past May at the Convention in Edmonton and was further discussed again at this meeting. Speaker Policy as proposed at the February 10th 2008 Meeting to be voted on at the September 21st Meeting

Each year CAOAC shall earmark an amount up to \$1,000.00 for support of speaker sponsorship. 50% of the amount allocated shall be made available to the club sponsoring the CAOAC Annual Convention. 25% shall be made available to each of the two clubs that in the opinion of the executive meets the following criteria:

Applications must be received by the CAOAC Executive prior to the November CAOAC meeting for sponsorship for the following year.

The speaker must be one that will promote interest in the aquarium hobby.

The club must undertake to publicize the event beyond their regular membership

Preference will be given to allocate the monies geographically i.e. West and East when CAOAC Annual Convention is hosted in Ontario

Preference will be given to co-operative events by more than one CAOAC member club

Clubs receiving funds must give a report after the event detailing attendance and what efforts were made to publicize the event.

Clubs are encouraged to tape or record the presentation with the consent of the presenter and to make a copy available for the CAOAC library.
