There will be NO exceptions. Discussion on how to encourage attendance at these meetings from members clubs and discussion also on how to increase the membership nationally.

**COMMITTEE REPORTS**

**Archivist:** Paul and Carl have agreed to co-chair this committee with Carl responsible for storage of the archives.

**AH Directory:** Nothing to report.

**Awards:** All the 2008 awards have been corrected and distributed to the recipients. Ken Ealy will be sent a new judging certificate.

Discussion about the Web Award and the Newsletter Award for 2007 –complaints were heard about the judging of these awards for 2007 but nothing was received in writing by the Awards Committee. The Awards Committee could not get any group outside of CAOAC to judge the award for 2007 so rather than not award it, decided to judge the websites ourselves. Once again CAOAC will attempt to obtain outside judging for the Web Award and pay an honorarium for this (similar to the Newsletter Award). Tony Bernard (President/FishRescueProgram) and Dave Boehm (Treasurer/AHDir/Webmaster) will set this up and report back at the next meeting. We decided to have the web sites judged in a specific time period rather than over a year and the clubs will be notified of the judging period. **For the 2008 competition the judging will take place January 1 – 31 2009** and in subsequent years the judging will take place in November of each year. The judging period will be added to the Calendar of Events and be advertized in the Newsletter. **Clubs that are registered for 2008 are – Brant, Calgary, Durham, Kwas and Regina and they will be notified by email by Miecia Burden (Recording Secretary/Membership/Binder/Newsletter) re the judging period.**
