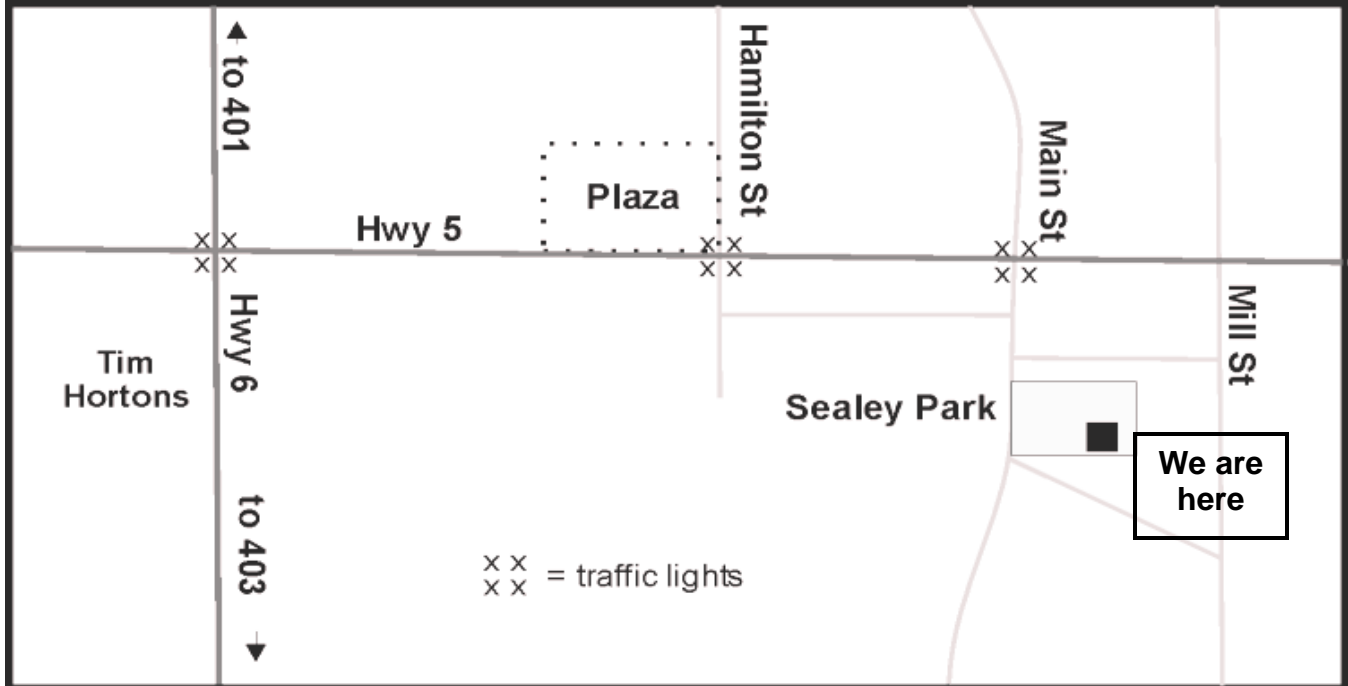

**Matters arising from Previous Minutes:**

Steve Crawford raised the question if all clubs had submitted their individual AHAP and BAP rules to CAOAC. (This was raised at the March meeting)

- After a discussion it was determined that this was asking if this was required. It was determined that it is not required that clubs provide their rules to CAOAC.
- The minutes from March minutes were not voted on for approval due to the lateness of the distribution and the fact names of award recipients were included. and Halifax. Carl advised that we should have a table at the Mississauga shows. Carl will inform Bob with more specific details of the dates, etc. It was determined that Noel Wright will be the contact for this.

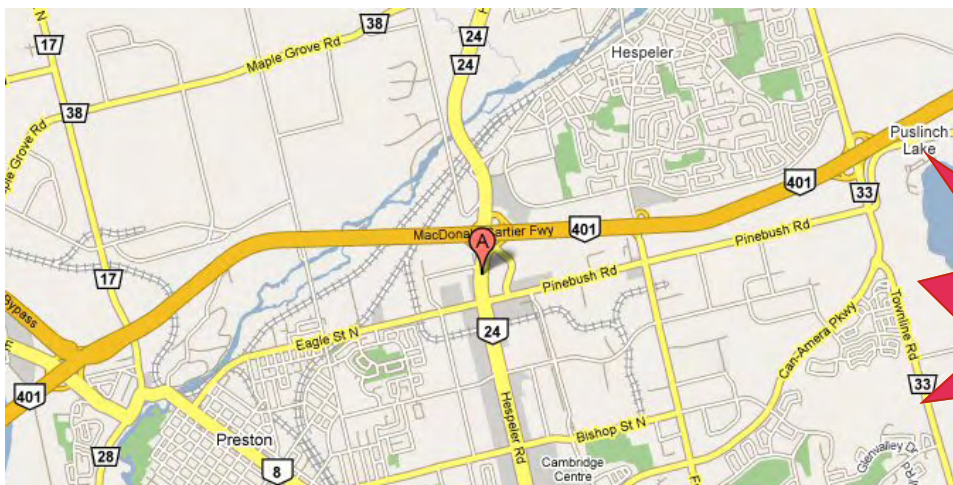
